

NOTICE TO CONTRACTORS AND  
INVITATION/ADVERTISEMENT FOR BIDS

Sealed bids for the US Highway #1 12-inch Water Line Extension for the Gilbert Summit Rural Water District will be received in their office located at 136 Hampton St. Gilbert, SC 29054 until **2:00 P.M. on March 24, 2020** at which time they will be publicly opened and read. All sealed bids MUST be in the physical possession of the Gilbert Summit Rural Water District on or before the exact date and time indicated above. Bids after this date and time shall be disqualified and shall not be opened. Sealed bids should be clearly marked “Bid Package for US Highway #1 12-inch Water Line Extension” with the bidder’s name, address, and South Carolina Contractor’s license number on the outside of the envelope. Sealed Bids submitted by mail and/or carrier must meet the same requirements and should be delivered to the address listed above. No bid shall be accepted by telephone, email, or facsimile.

The work under this Contract will consist generally of the following:

- Installation of approximately 5,100 LF of 12-inch water line, five (5) fire hydrants, and all associated appurtenances.

**Bids must be accompanied by a certified check or Bid Bond in the amount of five percent of the amount bid. The successful bidder must be able to provide a Payment Bond and Performance Bond within ten days of Notice of Award. These bonds must be in the amount of 100 percent of the contract amount.**

**No bid will be considered unless the bidder is legally qualified under the provisions of the South Carolina Contractor’s Licensing Law (South Carolina Code of Laws Chapter 11, Sections 40-11-10 through 40-11-428). Contractors shall have a classification of WL.**

**Bidders on this work will be required to comply with the President’s Executive Order No. 11246 & Order No. 11375 which prohibits discrimination in employment regarding race, creed, color, sex, or national origin.**

A non-collusion affidavit must be completed and submitted with the bid.

The Gilbert Summit Rural Water District reserves the right to reject any or all bids and to waive technicalities and informalities.
